
Prof. (Dr.) G. Nalankilli (Director) and Chairman of the Academic committee joined the meeting in online mode.


Various points were discussed and the following decisions are taken in the meeting:

1. It is observed that initial 10% fee (Rs. 47,209.44) for Accreditation was deposited on 20 February 2023 (Page no.1). However, the e-mail from NBA is received on 28-3-2023 regarding the extension of Accreditation for one year (i.e Upto 30 June 2024). Considering the Email Dt 28-3-2023 (Page No.2) and minutes of meetings of IT (Page No.3) EE (Page No.4) and APSH (Page No.5), it is decided that since NBA is already giving one year extension for "Accreditation", so the ongoing application process will be dropped now and remaining 90% fee will not be deposited and will forgo the already deposited 10% fee. Fresh application will be filed when the "Accreditation" status will about to expire or as per the decision taken at that time.

Dear Madam/Sir,

As you are aware, NBA as a policy has been considering Tier II Institutions in TEQIP III in the backward areas temporarily for grant of accreditation for 2 years under a separate category. In particular, the programs of TEQIP III Tier II Institutions are considered without asking for pre-qualifiers and 2 years accreditation is granted if such Institution scores 600 and above marks.

2. NBA has now decided that all such UG Engineering Programs of TEQIP III Tier II Institutions accredited for 2 years and whose validity of accreditation is expiring on 30-06-2023 or afterwards, would be considered for accreditation of (2+1)/ (2+4) years if they satisfy all the essential parameters of pre-qualifiers for accreditation of 3/6 years.

3. The following UG Engineering programs of your Institution have been granted accreditation by NBA for a period of 2 years in Tier II vide NBA's letter No. 35-153/2018-NBA dated 18/04/2022 as per the details mentioned below:
