MEMORANDUM OF UNDERSTANDING

Sharing a common desire to explore, extend and strengthen the functional relationship between **Rajkiya Engineering College(REC), Ambedkar Nagar** and **Rajkiya Engineering College (REC), Mainpuri** in order to share the facilities and expertise available in each other's institution herewith sign a Memorandum of Understanding (MoU), which reads as follows:

- 1) REC, Ambedkar Nagar will provide short term training to students and faculty members of the Rajkiya Engineering College, Mainpuri in their areas of specialization.
- 2) Trainees will work on REC, Ambedkar Nagar/Rajkiya Engineering College, Mainpuri projects and pertaining front line areas as per the mandated activities of the College/University.
- 3) Rajkiya Engineering College, Mainpuri, and REC, Ambedkar Nagar, may apply for collaborative projects jointly to National and International funding agencies.
- 4) The above MoU will be effective minimum for a period of five years.
- 5) This MoU reflects the respective college's commitments to terms and conditions mentioned in the MoU. This MoU may be amended at any time and terminated after completion of five years' time by either party provided that notice of termination or amendments is provided by the notifying party to the other party within thirty (30) days of the date on which the termination shall not have effect on any arrangement in place at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.
- 6) The students of Rajkiya Engineering College Mainpuri attached in REC Ambedkar Nagar, who will, while working/ undergoing of Ph.D./M.Tech. cause any damage to any part of the laboratory/ instruments due to negligence of the student then they will be held responsible for the damage

and the cost involved in damage will be recovered from the student either by the concerned College (REC Mainpuri or REC, Ambedkar Nagar).

- 7) REC Mainpuri/ REC Ambedkar Nagar will have the responsibility only to provide the laboratory facilities. The expenditure for the high cost consumable material required for the study should be met out by the students themselves.
- 8) While carrying out of the study at Rajkiya Engineering College, Mainpuri/ REC, Ambedkar Nagar the discipline's Head of the department of the REC Mainpuri/ REC, Ambedkar Nagar will be the controller of the student and they will be bound to get permission to leave the place of the study of REC Mainpuri/ REC, Ambedkar Nagar from the controlling authority.
- 9) The working/ stay hours of the student will be fixed as per the discretion of the Rajkiya Engineering College, Mainpuri/ REC, Ambedkar Nagar.
- 10) The student will be expected to protect the Intellectual Property Rights (IPR) generated or likely to be generated during his/ her research work. The IPR shall rest with institution where the major part of the research work was carried out by the student. In the event of equal amount of work being carried out at both the colleges, patents/ protections/ knowledge generated will be shared in proportion as per the REC Mainpuri and REC Ambedkar Nagar guidelines for Intellectual Property Management and Technology Transfer/ Commercialization as amended from time to time.
- 11) Research findings will be published jointly by both the parties, but the party communicating the publication/ corresponding author will be held entirely responsible for the conclusions and interpretations reported.
- 12) REC Mainpuri may invite REC, Ambedkar Nagar Faculty Members/ Experts as visiting faculty members to deliver lectures as per requirement of the REC Mainpuri in various courses/ capacities. However, TA and DA may be borne by the REC Mainpuri and vice-versa. Suitable honorarium may also be given to concerned College staff as per REC Mainpuri rules. The 'Rajkiya Engineering College, Mainpuri' and the college 'REC, Ambedkar Nagar'

may invite each other's faculty members on special occasions to develop strong linkages.

- 13) The REC, Mainpuri Faculty Members recognized by the Rajkiya Engineering College, Ambedkar Nagar and the research scholars who work at REC, Ambedkar Nagar for PG/ thesis research shall be governed by relevant rules and regulations of both the RECs.
- 14) The research project to be undertaken by the student/ research scholar shall be decided through mutual consultation between the student/research scholar, supervisor/ guide, and co-supervisor/ co-guide and shall normally be within the mandates of REC, Ambedkar Nagar/ Rajkiya Engineering College, Mainpuri and priorities set by the REC, Ambedkar Nagar and the University.
- 15) Periodical meetings of the students'/ research scholars with supervisors/ co-supervisors will be held at the premises of REC, Ambedkar Nagar/ Rajkiya Engineering College, Mainpuri.
- 16) A copy of the thesis shall be submitted at REC, Ambedkar Nagar after the award of the degree, if work has also been done in REC, Ambedkar Nagar Laboratories.
- 17) The Dean of the concerned faculty at REC, Mainpuri and REC, Ambedkar Nagar, will be jointly responsible for working out the operational details of the agreement between the two organizations and ensure proper and effective implementation of the MoU. During the study period at both the institutes, the Principal/Head of the REC Ambedkar Nagar and REC Mainpuri will be the controlling authority and the candidate shall be bound to get permission to leave the place of work from the controlling authority.
- 18) This agreement will be in-effect from the date of signing this MoU by both the parties and renewed further if mutually agreed upon. Either party may terminate the agreement by written notification signed by authorized official of the respective colleges initiating the notice. Such notice must be received by the other party six months prior to the effective termination date. However, obligations and commitments already contracted shall be honored.

and continued by both the parties until such commitments are over. These commitments under agreement may be amended/modified/deleted after mutual agreement by means of exchange of letters between the institute and the university. Once approved by both the parties, such amendment shall also become a part of this **Memorandum of Understanding (MoU)**.
