# **Memorandum of Understanding**



POLYTECHNIC, AMBEDKARNAGAR**

For the purpose of collaboration in both education and academic research, Rajkiya Engineering College, Ambedkar Nagar (REC) and Chhatrapati Shahuji Maharaj Government Polytechnic, Ambedkarnagar hereby affirm their intent to promote academic cooperation and exchange which will be of mutual benefit to respective institutions. REC and Government Polytechnic agree to encourage academic cooperation through the stated objectives outlined below:

- a. Collaborative research, lectures, and conferences in areas of common interest as per prevailing norms at both institutions.
  - b. Exchange of scholars and researchers as per prevailing norms at both institutions.
  - c. Exchange of data, documentation and research materials as per prevailing norms at both institutions.
  - d. Exchange of students as per prevailing norms at both organizations
  - e. Exchange of academic information and publications in areas of common interest as per prevailing norms
  - f. Any other collaborative efforts that may be beneficial to both Institutions with mutual consent.
2. Collaborative activities or projects between the Institutions will be subject to further agreement detailing the Institutions' responsibilities and obligations with the conditions related to each activity or project.
  3. It is agreed that the terms and conditions of any agreed programme and activity contemplated in this MoU shall be the subject matter of separate written agreements to be negotiated and agreed upon by both Institutions and/or any third parties, wherever applicable, PROVIDED ALWAYS, the decision whether to initiate and/or implement any programme or activity shall be at each Institution's sole discretion.

4. This memorandum is not intended to create binding or legal obligations on either Institution. It merely expresses the intentions and understanding of the Institutions, which will form the basis of any legally binding agreement to be drafted and executed in the future.
5. Both Institutions understand and agree that this memorandum creates no financial obligations on either Institution, and all financial arrangements will have to be negotiated and will depend on the availability of funds.
6. Rights regarding publications, patents, royalty, ownership of software/design/product developed, etc., under the scope of this MoU, shall be decided on a case-to-case basis. Neither Institution shall use the name of the other in promotional or marketing literature or information in any manner including social media without the prior written approval of the competent authority of the other Institution.
7. The Institutions agree and undertake to keep confidential at all times any confidential information or data that may be exchanged, acquired or shared in connection with any programme or activity conducted pursuant to this MoU save where the same is already in the public domain, obligated by law or otherwise defined in any subsequent agreement on the subject matter.
8. This Memorandum of Understanding shall become effective on the date of signing for (05) years and may be renewed for successive (05) years period with the mutual approval of both Parties, confirmed in writing and signed by both the Parties, unless either Institution gives the other Institution a written notice of its desire to terminate or to revise the Memorandum of Understanding six (6) months prior to the termination of a given (05) years period.
9. Any dispute arising out of this MoU will be resolved amicably by mutual consultation. If such a resolution is not possible, then the unresolved dispute will be referred jointly to the Director, REC Ambedkar Nagar and the Principal, Chhatrapati Shahuji Maharaj Government Polytechnic, Ambedkarnagar. The outcome of the joint decisions shall be binding upon both Institutions.
10. This Memorandum of Understanding will be executed in two (2) copies in English. This MoU will be **effective from**   13   **day of**   JANUARY  , 2026
