The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Rajkiya Engineering College Ambedkar Nagar, Akbarpur – Tanda Road, In Front of Hawai Patti, Katariya Yakoobpur, Ambedkar Nagar, Uttar Pradesh -224 122** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
